AGREEMENT TO OFFICIAL RULES: By submitting an entry, you represent and warrant that you meet the Eligibility requirements set forth in these Official Rules and agree to be bound by these Official Rules and any other requirements designated by Sponsor. Login: “Login” using BANDAI NAMCO ID or sign in as a GUNDAM.INFO member to participate in the campaign

Survey: First time entrants of this campaign are required to complete a full survey. Repeat entrants of this campaign are required to complete a short survey.

Serial Code: Enter the 16-digit serial code printed on the campaign card.

Entry History: Review entry history from the “ENTRY HISTORY” page.

Potential winners will be notified by email within seven (7) business days following the random drawing and will be asked to respond within seven (7) days and provide their full name, telephone number (including area code), date of birth, and mailing address.
